# Minutes of the Vowchurch Group Parish Council meeting held on Thursday 18<sup>th</sup> October 2018 at 7.30pm in Newton Church Room

- 1. ACCEPT APOLOGIES FOR ABSENCE Ms E May, Mr E Williams and Ward Councillor Peter Jinman.
- 2. RECEIVE DECLARATIONS OF INTEREST & CONSIDER ANY WRITTEN APPLICATIONS FOR DISPENSATION

   There were no declarations of interest or written requests for dispensation.
- **3. ADOPT MINUTES OF THE PREVIOUS ORDINARY MEETING** 20<sup>th</sup> September 2018 The minutes were signed as a true and accurate record.
- **4. OPEN DISCUSSION** No members of the public attended the meeting therefore no specific points were raised.
- 5. REPORTS
- **5.1** Local Police The local police were unable to attend the meeting.
- **5.2** Ward Councillor Ward Councillor Peter Jinman was unable to attend the meeting.
- 5.3 Lengthsman report Mr T Griffiths was unable to attend the meeting. His latest reports had been distributed to Councillors prior to the meeting via email. The Clerk had contacted the Locality Steward regarding outstanding repairs. Some have been completed and the fallen barriers have been reinstated, this job will be completed shortly. A response from the Lengthsman has been forwarded to Councillors regarding work on the gullies near the Kings Arms, Michaelchurch Escley. A request was made for the Lengthsman to clean the Vowchurch road signs on the B4348. Clerk to contact the Waterboard reporting a leak on the C1206, Slough Hill.
- **6. CLERKS UPDATE** The latest road closure schedules had been sent to Councillors and included a road closure on the B4348 at Vowchurch bend on 8<sup>th</sup> & 9<sup>th</sup> November and the C1206 at Michaelchurch Escley Bridge on 23<sup>rd</sup> October.
  - A notice of Confirmation of Modification Order has been received regarding the addition of restricted byways ME38, CZ46 and DO16, addition of bridleways ME40, ME41 and CZ47 and upgrading of footpath ME9 (part) to restricted byway ME39. A copy of the Notice of Confirmation will appear in the Hereford Times on 4<sup>th</sup> October 2018.
  - Herefordshire Council in partnership with Keep Herefordshire Warm are highlighting the problems with fuel poverty in Herefordshire and the help currently available. Herefordshire was defined as having the third worst percentage of people living in fuel poverty in the country. Keep Herefordshire Warm offers free home energy advice and support. The Clerk has put some information on the website and leaflets are available.

The Locality Steward is looking at having the bus stop sign replaced and possibly moving it to a safer place on the B4348 at the junction with the U75402 at Vowchurch Common, where people currently stand. After researching on google earth the Locality Steward queried whether a directional sign to Michaelchurch, Craswall etc. was ever in fact at this junction. It was agreed that Councillors do not remember seeing one.

Correspondence has been received regarding oversized vehicles continuing to use the U75402 to Vowchurch Common with a suggestion of writing to the Vowchurch Community to highlight the problem. It was agreed to look at this once the new sign has been erected. As previously advised the

Council are unable to help with any enforceable restrictions and would suggest that it is the owner's responsibility to protect their own property.

The landowner has since advised the Parish Council that their comments are now out of date as the route has been changed after recommendations from the Open Spaces Society. The Parish Council had not been aware of the new proposed route. As such the agreed response has not been sent to the Public Rights of Way Officer.
  - It was suggested that the Public Rights of Way Officer now makes the order for a full consultation to take place when the Parish Council and local residents can make comment. **All agreed.**
