## Minutes of the Vowchurch Group Parish Council meeting held on Thursday 21<sup>st</sup> June 2018 at 7.30pm in Newton Church Room

PRESENT – Mr P Mason (Chairman), Mr S Cole, Mr H Franklin and Mr K Hortin.

IN ATTENDANCE – Mrs L Cowles (Clerk), PCSO Fiona Witcher and one member of the public.

- **1. ACCEPT APOLOGIES FOR ABSENCE** Ms E May, Mr A Picton, Mr E Williams, Mr T Williams and Ward Councillor Peter Jinman.
- 2. RECEIVE DECLARATIONS OF INTEREST & CONSIDER ANY WRITTEN APPLICATIONS FOR DISPENSATION

   Mr S Cole declared a non-disclosable interest in agenda item 7.5; the declaration book was signed accordingly. There were no written applications for dispensation.
- **3. ADOPT MINUTES OF THE ANNUAL MEETING OF THE PARISH COUNCIL** 17<sup>th</sup> May 2018 The minutes were signed as a true and accurate record.
- 4. OPEN DISCUSSION The member of the public present raised concerns regarding oversized vehicles using the Vowchurch Common road which are damaging private property, banks and verges. Parish Councillors were shown video footage of a recent incident at their property. In the past large vehicles have been left at the bottom of the lane. Companies know that larger vehicles should not be taken up to the common and many residents normally advise delivery companies to use smaller vehicles, although this is often ignored by drivers. With several properties in the process of being refurbished, can more robust action be taken to stop larger vehicles using the road and can there be more signage? They would also like to erect a post to protect their bank from further erosion. The road sign and bus stop sign on the B4348 and C1206 junction have also been damaged after an accident some time ago, can these be replaced?

Mr S Cole advised that there are road curbs that can be used to discourage lorries destroying banks and this may be an option to take up with Balfour Beatty. He also suggested contacting them before any posts were installed within one metre of the highway. Any prohibition of large lorries using the road would need the support of the majority of residents. It was agreed that the Parish Council would contact Herefordshire Council to see what action could be taken to discourage larger vehicles using the road and it was suggested that the resident also contact Ward Councillor Peter Jinman.

The Clerk advised that the damaged road sign had been reported to the Locality Steward and the bus stop sign would be the bus company's responsibility.

### 5. REPORTS

- 5.1 Local Police PCSO Fiona Witcher had nothing to report other than to remind people to report any scrap metal dealers who cold call. There is currently a known scrap metal dealer in the area who doesn't hold a licence calling at domestic properties asking for scrap. Please make sure that all dealers hold a waste carriage licence and if they don't, report it.
- **5.2** Ward Councillor Ward Councillor Peter Jinman was unable to attend the meeting.
- **5.3** Lengthsman report Mr T Griffiths was unable to attend the meeting. There were no new road defects to report.
- 6. CLERKS UPDATE The Clerk reminded Councillors about Herefordshire Council's Budget Consultation which will take place on 4<sup>th</sup> July 2018 and any responses to the PCC survey of Town and Parish Councils need to be submitted by 6<sup>th</sup> July 2018. A planning application at Graig Farm Barn, Middle Maescoed has been received (182118) for Prior notification of agricultural or forestry development. Herefordshire Council are not accepting any comments on the application. Further correspondence received from a local resident regarding footpath VO57/53 was noted. The amended Neighbourhood Plan statement had now been added to the website. Mr Chris Robinson has now completed the renovation work on the parish noticeboards. He has asked that a couple of things are brought to the Parish Councils

attention. The bench by the river at Vowchurch was in a state of partial collapse. He has made some basic repairs but it will need further attention in the long term. The glass on the large noticeboard at Michaelchurch is grubby on the inside but can't be cleaned as it is locked. Also, the area around the noticeboards and telephone exchange is very muddy and piled up with dead leaves and litter. It was agreed that Mr Hortin would enquire who the noticeboard belonged to.
