- **8.7 CERTIFICATE OF EXEMPTION 2018/19** The Certificate of Exemption 2018/19 for smaller authorities was approved and signed accordingly.
- 9. LENGTHSMAN ANNUAL MAINTENANCE PLAN It was agreed that the annual maintenance plan for 2019-20 would remain the same as the previous year with the Lengthsman working one day per month from April – September, increasing to two days per month from October – March. The Clerk will complete the plan accordingly and forward to Balfour Beatty.
- 10. ST MARY MAGDALENE'S CHURCH, TURNASTONE The Parish Council has become aware that Hereford Diocese are considering making changes to St Mary Magdalene church in Turnastone and are concerned that the wider community are unaware of any plans. There is a possible proposal to install a holiday pod within the church with the graveyard being used as a car park. It was agreed that the Parish Council would write to Mr Stephen Challenger at the Diocesan Advisory Committee for an update on any proposed works and to enquire if they have had any consultation with the wider local community.



- 11. GREEN LANE/BERRINGTON LANE, VOWCHURCH Some residents who live close to this application have been contacted by Herefordshire Ramblers to advise they have made an application to Herefordshire Council that the Definitive Map and Statement for the area be modified by adding and upgrading this to a restricted byway. The Clerk has contacted the Rights of way Team Leader who has confirmed that an application has been made but the applicant must notify the landowners first of all and that it would be sometime before the case is investigated. The Parish Councils main concern is that they do not want it to be used by motor vehicles. It was agreed that the Chairman and Clerk would write to the Ramblers Association to ask what they plan to do and why.
- **12. PARISH COUNCIL WEBSITE** Councillors were advised of the latest number of visitors to the website gathered by the Google analytics report. Mr Kernahan passed the log-in details to the Clerk to enable this to be monitored on a regular basis. It was agreed that the Clerk would contact GV Webdesign regarding how the website is protected and was the security regularly updated.
